

Tim,

You likely know that there has been an effort to save some remarkable native tropical fishes that are only found in our region of the United States. The effort to list these fishes as endangered and threatened has a nearly 50 year history starting with my late mentors and colleagues. Freshwater aquatic habitat loss and water pollution has not improved over these decades, but has declined endangering not only these fish species but the entire tributary and Indian River Lagoon ecosystem. Our regional aquatic plants and animals now need all the help they can practically receive.

The US Fish and Wildlife Service and I are planning a briefing session where they will present the measures to take in listing a species as endangered. It has been decided that a grass roots effort by concerned citizens through the respective environmental groups would give the greatest power in the petition effort to save the endangered tropical freshwater fishes found in the Loxahatchee, St. Lucie and St. Sebastian Rivers. Dr. Nikki Colangelo, Supervisor for USFWS Endangered Species Classification and Recovery, will present the petition qualifications for listing a species as endangered and the petition contents necessary for processing at USFWS. I would then follow with a brief introduction of the species concerned and the information we have on their biology relative to endangerment.

This will be an introductory meeting where the leaders in each group would learn the procedure for listing an endangered species, and why it is important in protecting, not only the particular fishes, but also the habitat and water quality in freshwaters that flow into the Indian River Lagoon.

We are now trying to settle on a time for this meeting before the end of March. What dates are best for you to attend such a meeting?

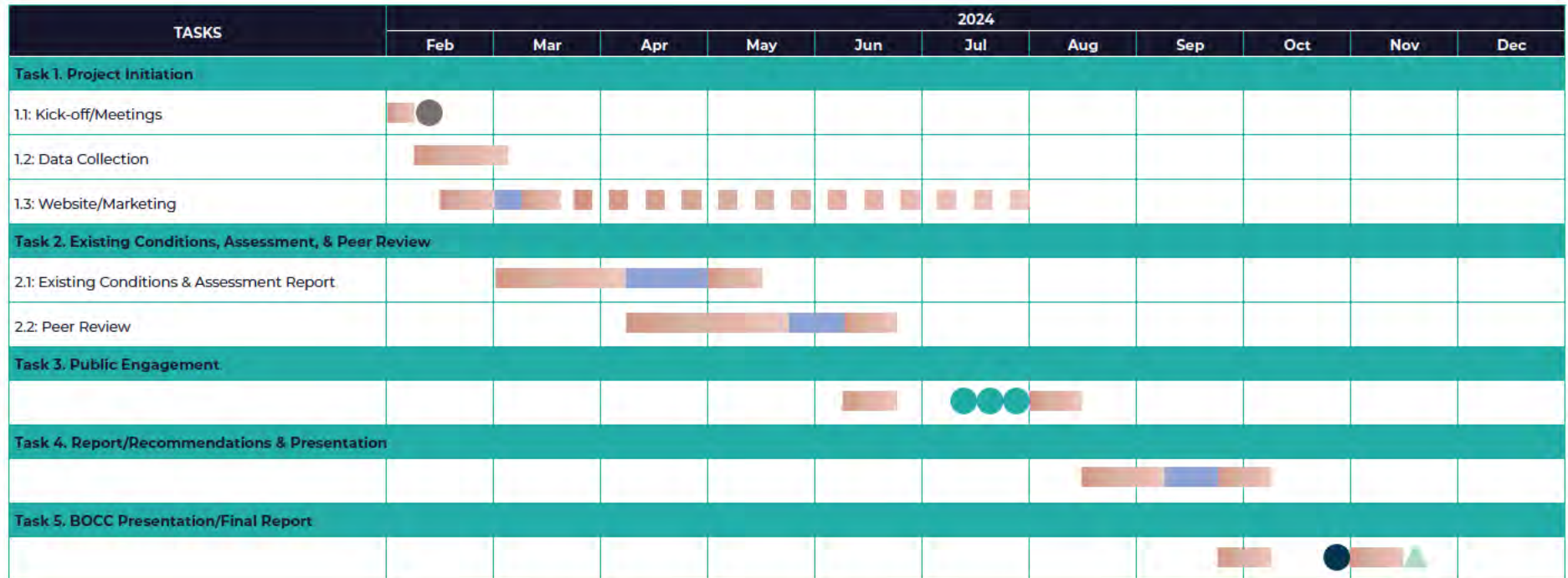
Good afternoon,

The County has chosen its consultant for the Urban Boundary Study, Inspire Placemaking Collective Inc. In the coming weeks, the County and the Consultant will have kick-off meetings to delve into the project. This project aims to evaluate and analyze the Urban Service Boundary (USB) and determine whether any adjustments need to be made. The study will focus on when, where, and how the boundary should be adjusted. Since any changes to the USB can significantly impact the community, it is crucial to gather public feedback through workshops and other means. The study will provide recommendations that can be incorporated into the County's Comprehensive Plan at a later stage.

A report on the Urban Service Boundary Study will be prepared and delivered by the Consultant, which will address the objectives of the Planning & Development Services Department. These objectives include but are not limited to, the following: providing an inventory of land within the current USB, including a breakdown of developed vs. vacant lands zoned for residential, commercial, and industrial uses; an inventory of existing residential units outside the USB; an analysis of the land required to accommodate projected residential, commercial, and industrial growth; an analysis of existing infrastructure capacity, including future needs based on projected growth; identification of areas for expanding the USB and preserving agricultural/conservation/natural lands; identification of at least two comparable areas in Florida that have moved their USB, and provide a relative comparison of the conditions in those instances to the conditions in Indian River County (based on the analysis of vacant/developed lands included in this study).

Community involvement is crucial in this process, and we need your participation. Throughout the project, there will be public workshops and online interactive activities. Please keep an eye on the website as well as your emails. This is to give notice that City of Fellsmere has determined that the following proposed action under the Florida Department of Economic Opportunity (DEO) Community Development Block Grant (CDBG) program and Contract No. 23DB-C02 is in the 100-year floodplain and/or wetland. The City of Fellsmere will be identifying and evaluating practicable alternatives to locating the action in the floodplain and/or wetland and the potential impacts on the floodplain and/or wetland from the proposed action, as required by Executive Order 11988 and/or 11990, in accordance with HUD regulations at 24 CFR 55.20 Subpart C Procedures for Making Determinations on Floodplain Management and Protection of Wetlands.

The City of Fellsmere will use \$700,000 of CDBG-CR funds to improve an existing Community Redevelopment Area beginning at the intersection of Fellsmere Rd. (CR512) and N. Broadway continuing northerly along N. Broadway to the intersection of S. Carolina Ave. and N. Broadway. The purpose of the project is to replace the existing roadway, sidewalks, and landscaping with new ten-foot-wide sidewalks consisting of zero-threshold entries for all existing commercial entities to ensure ADA access. The widened sidewalks will allow adequate space for streetside dining or retail with adequate room for street furniture and clear passage zones. Decorative paver crosswalks will be employed at all local road intersections. The on-street parking on both sides of N. Broadway will be shifted by four feet to allow for an expanded center median. This will result in the landscape strip between the sidewalk and the on-street parking going from 14' to 10' in width -- still adequate for a tree lined corridor. Street trees will be provided at regular intervals along the corridor with landscape emphasis at local road intersections. The expanded median will be 20' in width to accommodate additional landscaping, median cross-overs, and public benches. The travel lanes will be re-sloped toward the median to provide positive drainage. Additional runoff from roof gutters, parking areas, and patios contributed from adjacent private properties will also flow into the right-of-way and eventually into the local drainage. Finally, pedestrian scale lighting will be provided along the entire corridor.

### Improvements within the Floodplain

A FEMA special flood hazard area (floodplain) is located from the intersection of County Road 512 and N. Broadway and runs approximately 200' North along N. Broadway within the project area. As the travel lanes will be sloped towards the centerline median along N. Broadway, the drainage along N. Broadway may affect and/or impact the existing floodplain.

### Improvements within the Wetland

A riverine wetland which serves as a drainage canal along 98" Street is located at the most northerly part of Broadway. Additionally, a riverine wetland which serves as a drainage canal along New York

avenue is located with the project area at the intersection of N. Broadway St. and New York Ave. Additionally, as the travel lanes will be sloped towards the centerline median along N. Broadway, the drainage along N. Broadway may affect and/or connect to the riverine wetlands discussed above.

There are three primary purposes for this notice. First, people who may be affected by activities in floodplains and/or wetlands and those who have an interest in the protection of the natural environment should be given an opportunity to express their concerns and provide information about these areas. Commenters are encouraged to offer alternative sites outside of the floodplain and/or wetland, alternative methods to serve the same project purpose, and methods to minimize and mitigate impacts. Second, an adequate public notice program can be an important public educational tool. The dissemination of information and request for public comment about floodplains and/or wetlands can facilitate and enhance Federal efforts to reduce the risks and impacts associated with the occupancy and modification of these special areas. Third, as a matter of fairness, when the Federal government determines it will participate in actions taking place in floodplains and/or wetlands, it must inform those who may be put at greater or continued risk.

Thank you for your support for the EEL funding vote  
 We had a good crowd of 20+ supporters and speakers at the Commission meeting which definitely helps the Commissioners understand the importance of the program to the public.

#### The result of the vote was as follows:

- **The maintenance and operating costs for existing properties will be included in the County's aggregate tax millage not requiring it to be funded by bonds, which allows the potential to bond up to \$50M on land purchases alone.**
- **The Commission voted to acquire \$6.2M in bonds: \$3.2m for facility capital improvements and \$3M to purchase new properties.**

\$3M will not buy much property and was much lower than what we were hoping for, but it is a first and important step. One concern mentioned was that the cost of bonds is high now, but expected to decrease this year, so it might be best to hold off on purchasing large bonds until the rates come down. The problem with this is that the list of properties of interest are shrinking and may become more expensive offsetting any savings in bonds.



To those of you that were unable to attend because of conflicts, there will be another opportunity, when the specific properties to be purchased with the \$3M will come before the Commission for approval Stay tuned for more info

Purchase of these environmentally sensitive properties which, in many cases are low lying wetlands, is very important to the health of the lagoon because it prevents polluted stormwater from directly entering the lagoon or the St John's River It also reduces flooding of surrounding developed lands by allowing rainwater to percolate into the ground water table for drinking and irrigation

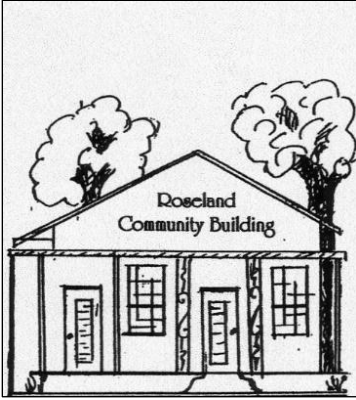
## **1000 Friends of Florida commentary on 2024 Florida legislative session, Senate Bill 7040**

SB 7040 / HB 7053 Ratification of Department of Environmental Protection Rules

SB 7040 (Environment and Natural Resources Committee) and HB 7053 (Water Quality, Supply & Treatment Subcommittee) ratifies the Florida Department of Environmental Protection (DEP)'s stormwater rules within Chapter 62-330 of the Florida Administrative Code. FDEP's rule would amend different components of state stormwater regulations, including minimum performance standards, maintenance and operation requirements, system design flexibilities, and would exempt existing permit holders and those currently under review from the rule's new requirements. The bill, however, adds additional changes to the rule language, including additional language grandfathering outstanding development projects. The bill also adds inspection requirement exceptions for activities and best management practices by the South Florida Water Management District pertaining to Everglades Program projects, and for Department of Agriculture and Consumer Services agricultural best management practices. The bill also **requires higher standards for nutrient reductions for redevelopment projects within an Outstanding Florida Water (OFW) subwatershed if located upstream of the OFW.**
