Advocacy Committee Report – Tim Glover  
January 9, 2024**

The following are notes from the Stormwater Master Plan Update presented to the Sebastian City Council, at their meeting on December 13, 2023, by the Plan consultant, Arcadis U.S., Inc. A copy of the Plan, broken into chapters, as well as a copy of the slideshow presentation by Arcadis, is available on the City's website at - <https://www.cityofsebastian.org/486/2023-Stormwater-Master-Plan-Information>.

Arcadis was not able to find any baseline data and therefore started from scratch.

They did a financial analysis of the City's budget and possible funding sources for the Plan, so as to create one that is realistic and should be achievable by the City.

The current City stormwater infrastructure can only handle an average 10-year storm event. A storm event of great than a 10-year average results in flooding.

Arcadis concluded there would be minimal sea-level rise effects on the City through 2050.

The City's stormwater department is understaffed and lacking equipment to just maintain the current system.

The City's Public Works Dept. needs a 41% increase in funding to maintain the status quo.

The City needs to reprioritize a 10-year capital improvement plan.

An increase in canal and stormwater storage capacity is needed.

There are a significant number of private stormwater systems draining to the City. Need to develop a system to certify these systems and ensure they are maintained.

City's Public Works Director, Karen Miller, has provided a 50-page executive summary of the Plan.

Mayor Dodd commented recognizing the impact of Sebastian stormwater on the IR Lagoon.

The Council anticipates many future workshops on a fleshed-out work plan.

Former Sebastian City Manager Paul Carlisle was in attendance.

**DESCRIPTIONS AND CONDITIONS**

The Florida Fish and Wildlife Conservation Commission (FWC) has authorized the removal of four (4) derelict vessels from the Indian River Lagoon and the St. Sebastian River within the jurisdiction of Indian River County. Officers from FWC have investigated the vessels and determined the vessels as derelict in accordance with sections 705.101 (3) and 823.11, Florida Statutes. The derelict designation from FWC allows for the vessels removed and properly disposed of, improving boating safety and removing these hazards to navigation and the environment. Outlaw Maritime, LLC has provided a cost proposal to the County of \$31,000.00 to remove and dispose of the four (4) authorized derelict vessels following FWC best management practices. Staff has prepared an FWC Bulk Derelict Vessel Grant application providing detailed information on the proposed removal tasks. The FWC Bulk Derelict Vessel Removal Grant is a reimbursement grant for 100% of the costs associated with the cost of derelict vessel removal.

**FUNDING**

The cost to remove and dispose of the four (4) derelict vessels totals \$31,000.00. If awarded, the FWC Bulk Derelict Vessel Removal Grant will provide the County with 100% reimbursement of the associated costs not to exceed \$31,000.00. This task is budgeted for in the Florida Boating Improvement Program – Other Contractual Service Account #13321072-033490.

# PROJECT SUMMARY

## Month Year Indian River County Derelict Vessel Removal

As of December 5, 2023, there have been four Authorization Letters issued for Derelict Vessel (DVs) removal within the boundaries of Indian River County. Indian River County, Coastal Engineering Division is coordinating the removal effort for all four vessels. The County is seeking an FWC Derelict Vessel Removal Grant for full reimbursement of the contracted amount for this project.

A licensed and insured contractor (Outlaw Maritime LLC) will be utilized by the County to properly and safely remove all three DVs adhering to the best management practices. A Scope of Work has been developed by County Staff to guide the Contractor in the removal.

The County will provide Natural Resources Staff to observe and photographically record the removal process. Photographs documenting the removal process will be incorporated into the final report. Local FWC Law Enforcement will also be offered to observe the removal process. Upon completion, Staff will inspect the removal locations to ensure all debris has been removed.

## SCOPE OF WORK

The County has sought removal quotes from Outlaw Maritime LLC to provide removal of the four derelict vessels (DVs) from the waters of the state, transport the vessels and vessel parts to an approved landfill facility and destroy the vessel. The contractor will use Florida Fish and Wildlife Conservation Commission’s Best Management Practices for Derelict Vessel Removal. This includes protective measures and equipment to prevent erosion and pollution during the removal process. Attached you will find maps and details of the DVs authorized for removal by the Florida Fish and Wildlife Conservation Commission Law Enforcement.

### Derelict Vessel Removal Background

Derelict vessels are navigational hazards to boaters, negatively impact the environment and are aesthetic nuisances. Typically these vessels are found grounded on the edges of active waterways where they may have physical impacts on benthic and shoreline communities. However, the impact of these vessels is not limited to their immediate location. If left unattended, the influences of winds and tides continue to push the boats, causing greater impact as they become more deeply mired into the environment. Early

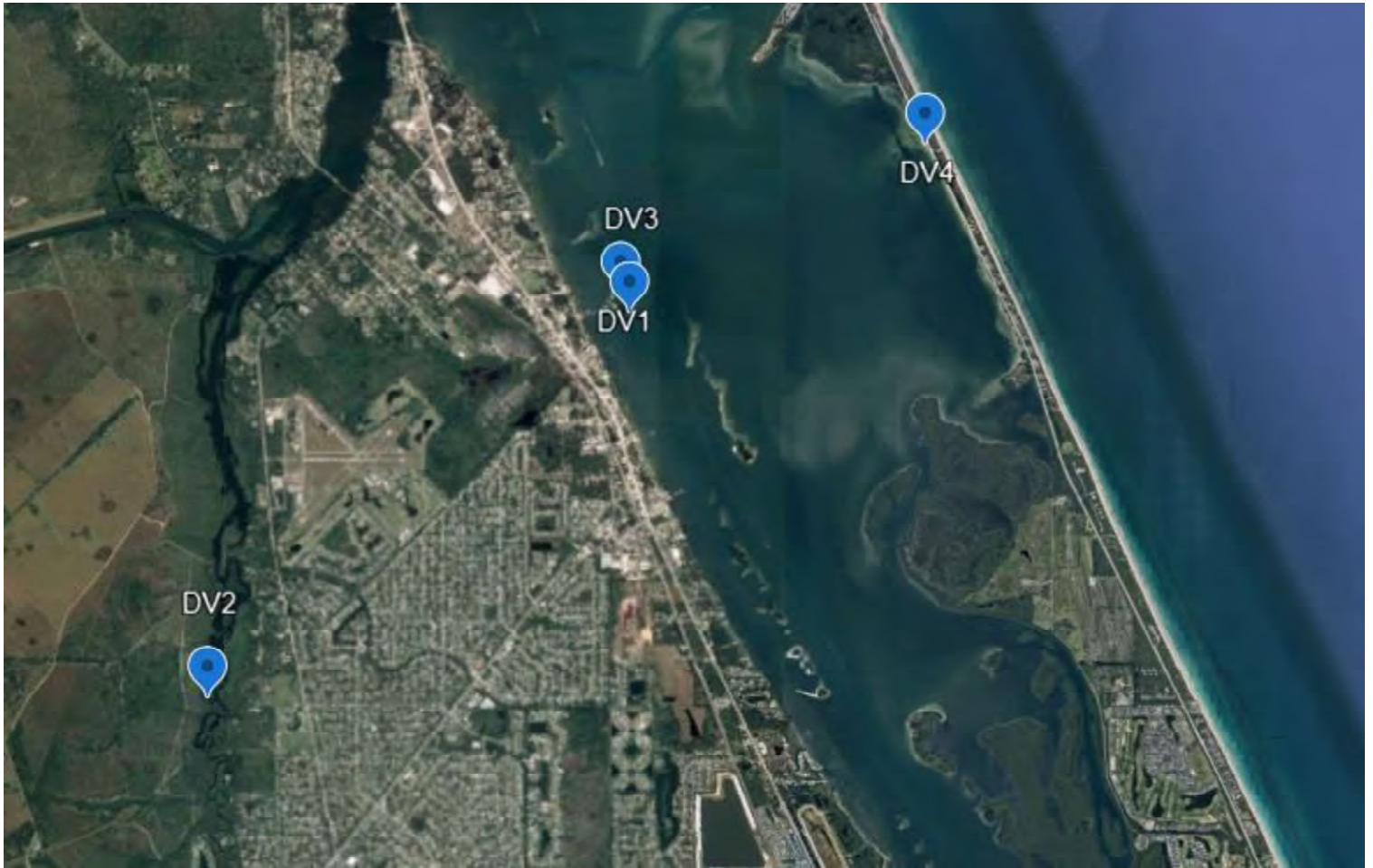

I want to update you on our efforts to qualify a "Right to Clean and Healthy Waters" Constitutional Amendment for the 2024 ballot. We needed approximately 900,000 petitions to qualify for the ballot and we collected approximately 115,000 petitions.

But we are not disappointed. Professionals in the campaign business tell us that collecting that many petitions through volunteer efforts and on a shoestring budget is extraordinary. That achievement is a testimony to the commitment of our volunteers and to the help of supporting organizations and individuals like you! (I go into more detail in this recent [op-ed](#) in which I announce our 2026 campaign.)

We are excited about our prospects for 2026. We know, however, that the upcoming campaign must be much better financed and make use of professionals who have campaign expertise we do not.

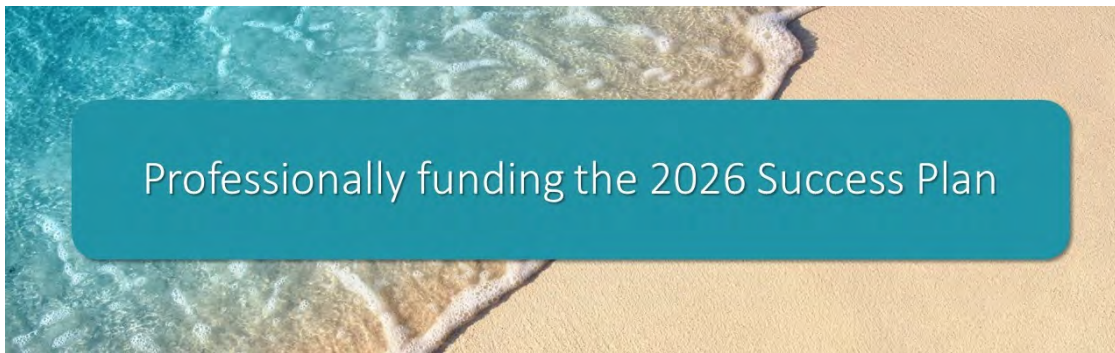

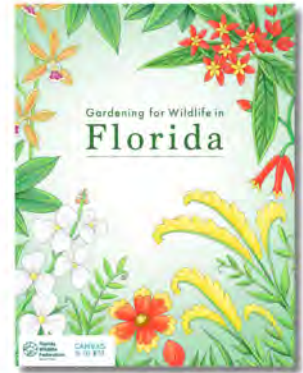
## How to Garden for Conservation

Not all conservation has to be on a large scale. Every one of us that has access to land can do our part. Our yards, neighborhoods, schools, parks, places of worship, even whole communities can become preserves that help sustain plants and animals. Even a small area can provide the elements needed by pollinators, birds and other native wildlife.

Every species has specific needs, but all require food, shelter, water, and space to raise their young. Native plants are an essential part of this equation. They are the base of the food web and provide flowers, seeds and fruits used by native pollinators, birds and other animals. Our native plants and animals evolved together, and wildlife needs native plants and trees to sustain their populations. You can have a beautiful landscape and provide these critical elements. If you make your yard attractive to wildlife, they will find it.

One of the most important ways we can help native plants and animals is by eliminating invasive species in our gardens and public parks. These unwelcome species are a major problem in Florida; they can rapidly run wild, threatening many natural areas by overgrowing native plants. Some of the removal of invasive plants can require using herbicides or machinery and may best be done by professionals. But we can take steps in our own gardens, yards and

### State Updates

#### **Governor releases budget**

The total recommended budget comes in at \$114.4 billion, more than \$4.6 billion than the current fiscal year budget. The Legislature will be the authors of the final 2024-2025 FY state budget, with Gov. DeSantis having the ability to line-item veto included provisions. The 2024 Legislative Session is set to begin January 9<sup>th</sup> and scheduled to conclude 60 days later on March 8<sup>th</sup>.

### **Federal Updates**

#### **IRS Increases Standard Mileage Rate to 67 Cents Per Mile for 2024**

This week, the Internal Revenue Service [issued a notice](#) raising the standard business mileage rate to 67 cents per mile for 2024 (up from 65.5 cents per mile for 2023). Many nonprofits use this rate when reimbursing their employees for work-related driving. The volunteer mileage rate – the amount that is tax-deductible when your nonprofit's volunteers drive on behalf of your organization – remains at 14 cents per mile and can only be changed by Congress.

#### **Some Nonprofits Will Need to File Corporate Transparency Act Reports in 2024 or 2025**

The [Corporate Transparency Act](#), a new federal law requiring business corporations to file annual reports with the Financial Crimes Enforcement Network (FinCEN), takes effect on January 1, 2024. **Generally, 501(c)(3) nonprofits are exempt from filing reports with FinCEN as long as they have current exemption letters from the IRS.**

However, [FinCEN's rules](#), which were finalized earlier this year, do not extend that exemption to nonprofit corporations whose tax-exemption determination has been revoked or is pending with the IRS. Specifically:

1. Nonprofits that have their 501(c)(3) status revoked by the IRS, including those that fail to file some version of Form 990 for three consecutive years, will need to file a report with FinCEN within 180 days after their tax-exempt status is revoked.
2. Nonprofits that have submitted Form 1023 or Form 1023-EZ with the IRS in 2023 or earlier will not need to file reports with FinCEN as long as they receive determination letters from the IRS by the end of 2024.
3. Nonprofits that are incorporated in 2024 or later will need to file reports with FinCEN if they do not receive IRS determination letters within 90 days after the date of their incorporation with the NC Secretary of State (or the equivalent agency in other states). Since many nonprofits do not apply for tax-exemption that quickly – and many more do not receive determination letters from the IRS within 90 days of incorporating – the Center is exploring ways to advocate for FinCEN to amend its rules to extend this 90-day period.
